How to take the photos RMC needs & how to get those photos to our office: All photos should show your side profile, in street clothes, with the bike on the center stand or held up by another person. 1) Rider only, feet on the pegs. 2) If ordering a dual, also include a photo of both rider and passenger seated together. 3) If you are vertically challenged, please also include a photo with the bike off the centerstand and your feet on the ground as though you are coming to a stop. Please note that these photos don't have to arrive at our shop until RMC begins production, so there's no rush, and that you are also free to send the photos via mail, email, fax, or with the seat itself.

Terms and Conditions- Rick Mayer Cycle may amend these terms (and the FAQ's) from time to time. Buyer agrees to accept additions or amendments and to consider them as part of this agreement. It is Buyer's responsibility to periodically check for updates or amendments. RMC builds only on unaltered stock seats, never after market seats, and will add \$75 to any seat modified from stock due to additional labor in our shop. RMC Pans are not sold; they are loaned. The deposit is non-taxable and is returned upon receipt of buyer's stock, unaltered, good-condition seat, after delivery of buyer's new custom seat. Buyer's stock seats must be received in our shop within 30 days of the date RMC shipped buyer's custom seats or buyer's deposit will be forfeited. There are NO EXCEPTIONS. It is buyer's responsibility to maintain a record of this shipment. If buyer cancels their check or it is returned for any reason, buyer agrees that their credit card will be charged their deposit fee. If a deposit is ever charged to a credit card, buyer agrees that a \$50 fee will be deducted from any future credit to cover our costs. Allow up to 30 days for any credits. Remove all hardware, hinges, rails, emblems, or other items before shipping. RMC cannot be responsible for these items if they are lost or damaged. All orders pay in US Funds. Attach additional comments on separate page if necessary. Buyer agrees that any disputes arising out of this transaction will be governed by California law without giving effect to its conflict of law principles. Buyer agrees that any disputes shall be instituted in a state or federal court in Shasta County, California, and the parties submit to the jurisdiction of any such court. **Buyers may apply only one special or discount to their order and may not stack additional discounts onto specials or sale prices except as specifically stated in that month's special. This includes redemption of a gift certificate and discounts given to members of law enforcement/ education, etc.** If you are applying a discount to buyer's order, the entire order must be prepaid in full.
